PRODUCT DESCRIPTION

Epifanes Rapidcoat is a fast drying, teak tinted, semigloss varnish alternative. This varnish provides good adhesion to all sorts of wood including teak. Sanding between coats is not absolutely necessary if the application of a subsequent coat is within 72 hours. Epifanes Rapidcoat is suitable for application on any other varnish regardless of brand. Provides a warm look of the teak wood and hides colour differences.

Field of use: All wooden parts and objects above the waterline. This varnish can be used for interior and exterior use. Also suited as quick drying impregnating base varnish coats prior to finishing with Epifanes Clear Varnish or Woodfinish Gloss/Matte.

The above mentioned drying times are indicative at 65% RAH and 30 µm dry filmthickness. Drying also depends on ventilation and applied wet filmthickness. Higher wet filmthickness and/or poor ventilation results in longer drying times. Especially horizontal parts may take longer to dry due to high wet filmthickness. Allow each varnish coat sufficient time to dry.

Substrate

New system: Degrease the wood with Epifanes Cleaning Solvent and sand bare wood with P180. After sanding degrease once more. On bare wood we advise to apply a first coat of Epifanes Rapidclear to neutralize possible colour differences due to the degree of absorption power of the wood. Thinning is not necessary. Apply as many coats of Rapidcoat to give the wood the colour that you wish. After you get the desired colour, switch to Epifanes Rapidclear and apply two or more coats

Existing system: Clean and degrease the varnish in place and sand with P240. Apply at least 2 coats of Epifanes Rapidcoat.

Best results are achieved by using a longhaired soft brush or by air spray. Because of the required wet filmthickness application by roller is not advised. Evenly distribute the varnish over the surface and tip off along the wood grain. Avoid retipping. Do not apply wet-on-wet. Do not apply excessive wet films to avoid the formation of curtains and drying problems. Avoid varnishing in direct sunlight or much wind. A rapid loss of solvents will occur under these conditions and this will decrease the flow. Avoid large differences in temperature of the product, surface to be varnish and working area. In case the product "pulls" and is difficult to apply, 10% thinner may be added. To retrieve intensify the original colour of the wood, up to 10% Epifanes Teak Stain may be added to the varnish. Sanding is not required if subsequent coat is applied within 72 hours. After 72 hours always sand with P320 or Scotch Brite. Always sand by hand along the wood grain.
