5.3. Advice for firefighters.

GENERAL INFORMATION

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health.

6. Accidental release measures.

6.1. Personal precautions, protective equipment and emergency procedures.

Eliminate sources of ignition (cigarettes, flames, sparks, etc.) from the air in which the leak occurred. 7. Handling and storage.

7.1. Precautions for safe handling.

Avoid the accumulation of electrostatic charges.
